Information Circular: Level 1 Regulatory Examinations Update

1. INTRODUCTION

This is a follow-up circular to FAIS circular 12/2012 distributed on 7 December 2012. The purpose of this circular is to communicate information regarding the following:

- Additional information regarding the extension of the deadline for the level 1 examinations;
- A summary of the dates applicable to the level 1 regulatory examinations;
- Registration for examinations;
- An update on the FSB/INSETA Assistance Workshop Project aimed at providing additional assistance to candidates who are struggling to successfully complete the level 1 regulatory examination by the due date.

2. THE EXTENSION OF THE "RE-WRITE" DEADLINE FOR THE LEVEL 1 REGULATORY EXAMINATIONS

With reference to the information already supplied in FAIS Information Circular 12/2012 regarding the extension of the deadline, the following addition should be noted:

Sole proprietors, key individuals and representatives authorized, approved or appointed during January 2010 to December 2010 will be included in the extension of the re-write deadline of 31 March 2013, provided that they have attempted the examination at least once by 31 December 2012.

3. SUMMARY OF THE DATES APPLICABLE TO THE LEVEL 1 REGULATORY EXAMINATION

3.1. The table below clarifies all the dates for all the level 1 regulatory examinations:

4.2. In the previous FAIS information circular 12/2012 it was explained that on-line examinations are available and a candidate can register for an on-line examination 2 days before writing the examination.

However, it must be clarified that the on-line examination is written at a specific examination venue of your choice, and therefore the examination bodies cannot accommodate on-line examinations registrations or examinations when they are closed.

This means that if a candidate would prefer to book an on-line examination, then the candidate would need to register for the on-line examination during the period that the examination body will open again in 2013.
