BYLAE

1. In hierdie Bylae beteken "die Regulasies" die regulasies afgekondig by Goewermentskennissgewing No. R. 2427 van 30 Oktober 1987, soos gewysig by Goewermentskennissgewing No. R. 952 van 3 Mei 1991.

Vervanging van die opskrif van die Regulasies

2. Die Regulasies word hierby gewysig deur die opskrif daarvan deur die volgende opskrif te vervang:

"REGULASIES BETREFFENDE DIE REGISTRASIE VAN STUDENT-MAATSKAPLIKE WERKERS EN DIE HOU VAN TUGONDERSOEKE".

Wysiging van regulasie 1 van die Regulasies

3. Regulasie 1 van die Regulasies word hierby gewysig deur die uitdrukking "Wet op Maatskaplike en Geassosieerde Werkers" te vervang deur die uitdrukking "Wet op Maatskaplike Werk".

Wysiging van regulasie 3 van die Regulasies

4. Regulasie 3 van die Regulasies word hierby gewysig—

"(1) 'n Student in die vak Maatskaplike Werk moet voor of op 31 Maart van die tweede studiejaar om registrasie as student-maatskaplike werker aansoek doen op 'n vorm wat van die registrateur verkrygbaar is.";

(b) deur paragraaf (d) van subregulasie (2) deur die volgende paragraaf te vervang:

"(d) die voorgeskrewe registrasiegeld.";

REGULATIONS REGARDING THE REGISTRATION OF STUDENT SOCIAL WORKERS AND THE HOLDING OF DISCIPLINARY INQUIRIES IN TERMS OF THE SOCIAL AND ASSOCIATED WORKERS ACT, 1978: AMENDMENT

The Minister for National Health and Welfare has, on the recommendation of the South African Council for Social Work, in terms of section 28 (1) of the Social Work Act, 1978 (Act No. 110 of 1978), made the regulations set out in the Schedule hereto.

SCHEDULE

1. In these regulations "the Regulations" means the regulations published by Government Notice No. R. 2427 of 30 October 1987, as amended by Government Notice No. R. 952 of 3 May 1991.

Substitution for the heading of the Regulations

2. The Regulations are hereby amended by the substitution for the heading thereof of the following heading:

"REGULATIONS REGARDING THE REGISTRATION OF STUDENT SOCIAL WORKERS AND THE HOLDING OF DISCIPLINARY INQUIRIES".

Amendment of regulation 1 of the Regulations

3. Regulation 1 of the Regulations is hereby amended by the substitution for the expression "Social and Associated Workers Act" of the expression "Social Work Act".

Amendment of regulation 3 of the Regulations

4. Regulation 3 of the Regulations is hereby amended by—

(a) the substitution for subregulation (1) of the following subregulation:

"(1) A student in the subject Social Work shall apply on or before 31 March of the second year of study for registration as a student social worker on a form obtainable from the registrar.";

(b) the substitution for paragraph (d) of subregulation (2) of the following paragraph:

"(d) the prescribed registration fee.";
